



Medication Assisted Treatment Funding Award Prevention and Education Implementation 2020-2022

Access Support Network Monterey County, San Luis Obispo County \$100,000.00

To ensure OUD/SUD outreach and support for Latinx communities accessing care by providing peer MOUD navigators and a provider at the SSP to ensure warm handoffs and connection to MOUD services in Monterey county with a similar expansion of services planned for San Luis Obispo county.

Fathers & Families of San Joaquin San Joaquin County \$100,000.00

To continue to support a SUD coalition that facilitates moving from a punishment to a healing model for OUD/SUD for Black, Indigenous, and People of Color in San Joaquin county, and utilizes SUD interns to address gaps in care and incorporate culturally rooted healing services into MAT prevention, outreach, and treatment.

InnerCity Struggle Los Angeles County \$100,000.00

To continue to provide community education and outreach around OUD/SUD/MAT by engaging community leaders to facilitate community outreach workshops, and by strengthening the established referral system to connect the Eastside Latinx community in Los Angeles county to comprehensive care and MAT treatment services.

Judahh Project Sacramento County \$100,000.00

To continue community OUD/SUD education campaigns with partners such as faith based organizations, businesses, and schools as well as have a community health worker to support African American communities in navigating the health care system and accessing MAT services in South Sacramento.

National Asian Pacific American Families Against Substance Abuse Los Angeles County \$100,000.00

To share findings from the community health equity plan on addressing OUD/SUD in Asian Pacific Islander communities in Los Angeles county with community partners and by training community outreach workers to create a trusted messenger network and strengthen the prevention and treatment referral system.

ProWellness Academy Los Angeles County, Riverside County, San Bernardino County \$100,000.00

To link African American, Latinx, and Native American communities in Los Angeles, Riverside, and San Bernardino counties to MOUD+Counseling services by providing direct access to treatment and strengthening the care affinity provider network.

Roots Community Health Center Alameda County, Santa Clara County \$100,000.00

To improve OUD/SUD services for African American communities in Alameda county by increasing connections with outreach sites and destigmatizing MAT treatments, enhancing therapeutic options by linking behavioral health and medical services, and continuing to provide staff education at MAT treatment locations.

School Health Clinics of Santa Clara County Santa Clara County \$100,000.00

To transition OUD/SUD/MAT services fully to telehealth to facilitate continued care with the Latinx community in Santa Clara county.

The Source LGBT+ Center, Inc. Tulare County \$100,000.00

To create a local OUD/SUD response for LGBT+ communities of color in Tulare county through rapid HIV/HCV testing, continued MAT warm handoffs and referrals, trauma-informed recovery support groups, and continuing a broad social media campaign, all of which have been successful in addressing local issues specific to accessing care.

The Wall Las Memorias Project (TWLMP) Los Angeles County

\$100,000.00

To create a SUD Action Committee of LGBTQ Latinx communities in Los Angeles county to implement a three pronged education campaign focused on individuals with leftover prescriptions and safe disposal, health care providers and patient education, and a general public harm reduction campaign specifically providing information on Naloxone.
