**\$229,090.00**

To implement a psycho-social care management program by hiring a Patient Care Manager and Case Worker to support treatment for gay men who use substances, particularly crystal meth, in Los Angeles County.

**Bayview Hunters Point Foundation for Community Improvement – Dimensions Clinic for Queer and Trans Youth**

**San Francisco County**

**\$250,000.00**

To increase 2S/LBTQ+ youth substance use disorder screenings, clinical case management, and referral to treatment in San Francisco County by hiring two outreach coordinators at Dimensions Clinic, facilitating outreach events and by developing local social media and website resources.

To provide opioid use disorder and substance use disorder educational counseling sessions and linkages to care to recently released 2S/LGBTQ+ individuals through the TranSend program as well as create a social media and community outreach campaign in Los Angeles County.
