Does the funding cover the equipment needed inside the Mobile Medication Unit?	Yes, please refer to the RFA, which lists appropriate expenses
Must applicants be on the Narcotic Treatment Program Provider directory list on the DHCS website to be able to apply for the grant?	The applicant must be a DHCS licensed NTP to apply.
Could you provide some good examples of MUs? Are these housed within a pharmacy, or do they maintain an office near the pharmacy?	MUs can be co-located at a pharmacy or be a separate facility. Some additional information can be found at this <u>link</u> .
After submission, will organizations receive a confirmation that the application has been received?	Yes, you should receive an automatic confirmation of submission. Please email <a href="mailto:centergrants@shfcenter.org">centergrants@shfcenter.org</a> if you do not receive notification.
Do nonprofit organizations have funding priority?	Not necessarily. Funding priority is based on multiple factors including applicants who plan to work with local DHCS-licensed residential SUD facilities that do not currently offer MAT. Page 3 of the RFA specifies: All NTPs are encouraged to apply, with priority being given to NTPs wanting to expand their services via an MU and/or an MNTP to prioritize rural communities, correctional facilities, local DHCS licensed residential substance use disorder facilities that do not offer MAT and Indigenous and Native communities. NTPs will also be prioritized for serving Medi-Cal beneficiaries.
For the financial question of "What is your annual budget amount?" is this asking what our organization revenue is?	This is requesting your annual organizational budget, not just revenue. This is because revenue would just be what you bring in, and we are looking for an actual budget.
The Center grant accountant speaks about depreciating the vehicle if the intention is to use it less than the 5 years over which depreciation is allowed. Can you confirm that if we plan to use it over the full five years there need be no budget line item for depreciation versus including depreciation applicable to the time from purchase?	The mobile unit awards are less than 18 month awards, and the useful life of a van or other vehicle is typically five years – if the asset will maintain the same use and purpose beyond the end of the award, then you may charge the entire cost of the asset to the award during your award period (this award is unique in that its purpose is to fund the infrastructure of putting mobile units into use). If you plan to repurpose the asset to an unrelated use after the award period is over, then it is only appropriate to charge a portion of the cost – with depreciation expense being a fine way to split out the amount that should be charged to the award.

On the RFA, under section "Project Overview," are multiple focus areas permitted? For example, we have three (3) target primary focus areas, Rural Communities, Residential Facilities, and Correctional Facilities, however we are only able to check 1 item on the portal.	If you have multiple priority focus areas, please select the "other" option. There you can fill in a response that is up to 255 words.
We noticed on the budget template it only covers a 6-month period, however the proposal is for 18 months. Is this correct? Or should it reflect the 18-month funding period?	The budget template provided has the three budget periods side by side, for the total of 18 months.
Is the DMC number required the 11 digit NPI number or the 6 digit calOMS number?	On the application we ask for the DMC 11 digit NPI number.
I interpret the question about congressional districts as being asked only for sponsored organizations. Can you confirm or do all applicants need to answer this question?	All applicants need to answer this question.
Does the Mobile Medication Unit have to be outside of the 5 mile radius of another OTP or can it exist within the 5 miles of its hub NTP? If we did put it outside of our 5 mile radius, in an area that is outside of the 5 mile radius, then will we be able to bill from our existing Medi-Cal contract or would we have to set up separate contracting, i.e. SAPC vs. Ventura County?	Please contact your county contractor's or Medi-Cal contractor for billing questions.
The budget template has two tabs. Do we fill both out for our application?	No, only fill out the first tab. The second tab will be used later on, if awarded funding.
Could you please describe the required attachment "Drug Medi-Cal Approval Letter" and the required "Drug Medi-Cal Number*:"	Please refer to this document ( <u>here</u> ).
We are interested in applying for Track Two: Mobile Narcotic Treatment Program, however, we would most likely contract this program with a vendor for services. Is that allowable with this grant?	DHCS licensed narcotic treatment programs are eligible applicants for this grant.
